BY SIGNING THIS DOCUMENT YOU WILL WAIVE LEGAL RIGHTS INCLUDING THE RIGHT TO SUE RigFest, Mythosaur Motorsports, Alex Puffenbarger, Robert Puffenbarger, and Jessi Puffenbarger(CampHost).

1. Participation. I, the undersigned, wish to participate in RigFest 2023 at Laser Town, Johnson Valley, Ca (Location).
2. Assumption of Risks. I wish to participate in the RigFest 2023 and hereby assume all risks of engaging in the RigFest 2023. I also hereby hold harmless and release Camp Host, its members, managers, employees, and agents (Indemnites), and indemnify each of them from and against any and all loss, claim, cause of action, lawsuit, damage, liability, cost, or expense whatsoever which any of them may incur arising out of or in connection with my participation in RigFest 2023 at the Location, including but not limited to the personal development and transformational activities to be conducted as part of the RigFest 2023; individual led activities whether or not they are motorized, this will apply to vehicles that either I own or any 3rd party vehicle driven; meals, food, and beverages served at the Location.
3. Waiver. I hereby certify that I am at least 18 years of age (or, if less than 18 years of age, have caused this Liability Waiver and Release to be signed by my parent or legal guardian), I agree that neither I nor any member of my family will sue any Indemnitee because of my participation in RigFest 2023 or my presence at the Location at any time, and I understand that this Release shall be binding upon my estate, my heirs, next of kin, executors, administrators, representatives, successors, and assigns. I specifically waive any claim or right to assert any cause of action or alleged cause of action or claim or demand which has, through oversight or error intentionally or unintentionally or through a mutual mistake, been omitted from this Liability Waiver and Release.
4. Covenants Regarding Participation in RigFest 2023. I further agree:
 - **To obey all rules developed by Camp Host for RigFest 2023 as well as the rules, regulations, and staff of Camp Host and agree that I may be removed from participation in RigFest 2023 and asked to leave the Location at any time for any reason that Camp Host's staff deems adequate;**

- **To be financially responsible for any and all damage that I may cause while at the Location, including but not limited to light fixtures, signage, structures and/or containers, personal property, and vehicles, it being understood that my right to use the Location may be terminated permanently at the sole discretion of Camp Host if I commit any violent acts while on the Location premises whether intentionally or negligently;**

6. Governing Law; Amendment; Interpretation of Agreement. This Liability Waiver and Release shall be governed by the laws of the State of California and that any action, claim, or proceeding under this Liability Waiver and Release shall be commenced exclusively in the Superior Courts of California, County of Los Angeles or the United States District Court for the Central District in the State of California. This Liability Waiver and Release may not be revoked, terminated, or amended verbally, but only by a written instrument signed by me and an authorized representative of Camp Host. All covenants contained herein are severable, and in the event of any being held invalid by any competent court, this Agreement shall remain intact except for the omission of the invalid covenant.
